

Course overview

The course aims to provide master's students a comprehensive introduction to methods of social research in social policy. This course covers the philosophical foundations of social policy research, fundamentals of positivist social research, survey research, using administrative data, quantitative comparative social policy analysis, qualitative methods in social policy research with a special focus on interviewing, qualitative content analysis, documentary analysis, social policy impact evaluation and research ethics. The objective of the course is to allow students to develop skills and knowledge about quantitative and qualitative social research, help them to better evaluate the quality of the published social research, formulate researchable questions, and design and carry out a research project.

The organization of classes

I will lecture around 40-50 minutes at the beginning of the class to set the scene. After Q & A session following the lecture, we will give a short break, which will be followed by in-class practical exercises.

I expect you to read each week's assignments before the class. Course requirements are as follows:
