ATA 596: Social Policy in Comparative Historical Perspective

Economic, social and cultural transformations of the last few decades have ushered in two seemingly contradictory developments in social policy regimes throughout the world. On the one hand, the mature welfare states of developed capitalist countries have come under pressure as a result of these transformations. In the countries of the peripery, on the other hand, we have observed a "social turn" whereby social protection has acquired a novel significance. This course is designed to approach the questions and challenges that emerge in this particular historical conjuncture through an investigation of the history and theory of social policy. The ultimate objective of the course is to initiate an inquiry into different modes of social solidarity in which markets, states, families and NGOs play different roles.

Course evaluation is based on a paper (around 15 pages) and a take-home final examination. Contribution to class discussions around the required readings is important.
